Terms and conditions: -

1. The Candidates must possess the minimum qualification of Matric & Maximum as 10+2.
2. For selection purposes 10th& 12th pass qualification only shall be considered and points shall be awarded as under:
 - 10th : 60 points (on prorata basis)
 - 12th : 20 points (on prorata basis)
 - Viva : 20 points
 - Total: 100 points
3. The age of the candidate as on 01-01-2016 should be:
 - i. Not below 18 years
 - ii. Not above:-
 - a. 40 years in case of Open Merit
 - b. 43 years in case of SC/ST/RBA/OSC candidates
 - c. 42 years in case of Physically Challenged candidates.
 - d. 48 years in case of Ex-Servicemen.
 - e. 40 years in case of candidates in Government Service/Contractual Employees
4. The application on prescribed format along with attested copies of the following certificates / documents shall be received at **OFFICE OF DEPUTY COMMISSIONER ANANTNAG.**
 - i. Date of Birth.
 - ii. Academic (Marks Certificate) Qualification Certificates.

7. All document attached with the application shall be signed by the applicant and pages numbered.
 8. The total No. Of pages (encls.) have to be mentioned both in words and figures.
 9. Candidates found guilty of impersonation or submitting false, fabricated and tampered documents /suppressing material information shall lead to the rejection of his/her candidature at any stage. Besides, such applicants are liable for criminal prosecution.
 10. The candidates shall have to appear before the selection committee for interview at the venue to be intimated later on their own expenses.
 11. The date of interview shall be notified separately, and no call letters shall be sent individually. However, the candidates in their own interest may contact Deputy Commissioner Office Anantnag, for any query regarding dates of interview. No claim of being unaware of interview shall be entertained.
 12. The candidates at the time of interview should be in possession of all the certificates / documents in original.
 13. The number of Posts as mentioned above may increase or decrease depending upon number of vacancies available at the time of final selection.
 14. If large number of applications are received, the selection committee will short list the candidates for interview. The short listing shall be done in the ratio of 1:5 based on the merit obtained in 10th and 12th and weightage to the 10th and 12th shall be assigned as mentioned above (Term/Condition No. 2).
