

INTERVIEW NOTICE

In continuation to this office No DCA/Estt/17-18/ 1491-94 dated 18.10.2017 whereby shortlist of the candidates for the post of sweeper cum Night Chowkidar was published, it is for the information of the concerned that interview shall be conducted on **17.03.2018 from 10.00 A.M at Dak Bungallow Khanabal.** It is further notified that:-

- 1) All/any additional qualifications / reserved category certificate acquired by the candidate after the last date of receipt of application forms shall not be entertained.
- 2) Mere figuring of name in the list does not entitle the candidate to appear in the interview as it shall be subject to the scrutiny of all testimonials of the candidates shortlisted.
- 3) No separate interview/call letter shall be issued to any candidate whose name figures in the said list and this notice shall be deemed to be interview call to appear before the Interview Committee on the schedule date, time and venue. A candidate who fails to appear in the interview on the given date shall not be interviewed later and shall forfeit his/her right of consideration.
- 4) In case of any deficiency with reference to eligibility etc proved at the time of interview, the candidate shall not be allowed to appear in the interview, or if any deficiency is found subsequently the candidate shall not be considered for selection and will be treated as disqualified.
- 5) The candidate shall have to produce all original certificates / testimonials as asked for vide above referred advertisement notification before the Interview Committee at the time of interview. The candidates who fail to produce such certificates / testimonials may forfeit their candidature.
- 6) Any candidate found guilty of impersonating or submitting fabricated / tampered documents / testimonials or making false / incorrect statement or suppressing material information shall be rendered liable to criminal prosecution under law and may be debarred permanently or for a specific period for consideration for any or all recruitments made by the Committee. Also canvassing / lobbying in any form will entail disqualification of the candidate.
- 7) No TA/DA shall be paid for participation in the interview.

Note; a) The candidates are advised to bring Photostat copy of each certificate self-attested by the candidate in addition to original documents, failing which no claim / objection in this regard shall be entertained.

(b) The candidates have been included in the interview list provisionally and only such candidates shall be allowed to appear in the interview who qualify the age criteria, possess valid category certificates and prescribed qualification on the cutoff date.
